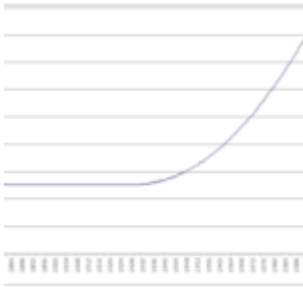


Climategate 4- Die Chronik eines wissenschaftlichen Skandals des IPCC Zulieferers CRU!



Ein anonymmer Kommentator hat auf der skeptischen Internet Seite noconsensus.wordpress.com einen Text mit folgendem Inhalt sowie den Link zu einem Dateiarchiv hinterlassen. Der Name der Datei ist "FOI2009.zip", womit wohl Bezug genommen wird auf den amerikanischen Freedom Information Act, der jedem US-Bürger das Recht zubilligt, Zugang zu Dokumenten der Exekutive (der Regierung) der Vereinigten Staaten zu verlange

We feel that climate science is, in the current situation, too important to be kept under wraps. We hereby release a random selection of correspondence, code, and documents

Die erwähnte Datei ist 61 Megabyte groß und enthält neben verschiedenen Dokumenten und Code-Dateien auch über Tausend E-Mails. Die betreffenden Dateien scheinen von der britischen Climate Research Unit (CRU) zu stammen und enthalten unter anderem Korrespondenz zwischen Klimaforschern.

Unter den E-Mails befindet sich Korrespondenz der Klimaforscher untereinander, zwischen Klimaforschern und Skeptikern und auch zwischen Umweltorganisationen und den Wissenschaftlern. In einigen Mails werden Details offenbart, welche die Forscher vermutlich lieber im engeren Kreis behalten hätten

Richtigkeit der Daten bestätigt

Nach anfänglichen Zweifeln stellte sich bald heraus, dass die Daten tatsächlich von der CRU stammten und echt sind. Das bestätigten sowohl Reporter, die in der Korrespondenz eigene Texte wiederfanden, als auch skeptische Wissenschaftler die ebenfalls die Echtheit ihrer E-mails in dem Datensatz bestätigten. Und sehr bald gestand auch Phil Jones, Direktor der Climate Research Unit, ein dass es einen Hackerangriff auf die Rechner seines Instituts gegeben habe und bestätigte damit hochhoffiziell die Echtheit der Daten.

Nachdem feststeht, dass die Dateien und E-Mails in der sogenannten [FOIA-Datei](#)

echt sind, findet in der internationalen Presse und in der Blogger-Szene eine intensive Debatte über den Inhalt der Dateien und über die Konsequenzen der Affäre statt.

Besonders diskutiert wird dabei der Inhalt der mehr als 1000 E-Mails. Schnell fanden sich im Internet Seiten, auf denen diese gelesen werden und nach Inhalten durchsucht werden konnten ([Alleged CRU Emails – Searchable](#)).

In diesen E-Mails kamen unter anderem Details darüber ans Tageslicht, wie Daten gezielt verändert wurden, damit sie das gewünschte Ergebnis zeigten. So wurden Datensätze, die eine Abkühlung zeigten einfach abgeschnitten und durch andere Daten ersetzt ([Mike's Trick](#) und auch hier in deutsch). Auch wurde besprochen, wie man unliebsame wissenschaftliche Publikationen aus dem IPCC-Report heraus halten wollte. Notfalls, so wurde diskutiert, würde man einfach das Verfahren zur Begutachtung (Peer-review) an die eigenen Bedürfnisse [anpassen](#). Und wenn das nicht klappte versuchte man die Publikation nach Möglichkeit zu [ignorieren](#).

Forscherkollegen, die nicht die „richtigen“ Ansichten vertraten wurden in den E-Mails auf äußerst diskreditierende Weise dargestellt. Einer der Klimawissenschaftler drückte in einem Schreiben sogar unverhohlen seine [Freude über den Tod](#) eines kritischen Kollegen aus.

Deutscher Klimaforscher fordert Ausschluss von Kollegen vom IPCC

Auch der prominente deutsche Klimawissenschaftler Professor von Storch vom GKSS-Forschungszentrum Geesthacht hat sich mit seinen kritischen Ansichten zur Politisierung der Klimawissenschaft nicht nur Freunde gemacht. Dementsprechend waren die Erwähnungen seines Namens in den E-Mails meist von wenig schmeichelhafter Art. Unter anderem wurde ihm vorgeworfen, die Klimawissenschaft zu zerstören, weil er Forschungsdaten an Gegenspieler weitergegeben habe. In einem anderen Schreiben freute sich Michael Mann darüber, dass er von Storch erfolgreich von einem Gutachtertreffen über historische Temperaturrekonstruktionen ausschließen konnte. Dabei konnte von Storch wegen der Menge der Daten bislang erst einen Teil des ihn betreffenden Briefverkehrs begutachten.

„Ich würde annehmen dass noch interessantere Punkte in den Dateien gefunden werden, und dass eine hilfreiche Debatte über den Grad der Politisierung der Klimawissenschaften entstehen wird.“

Angesichts des bekannt gewordenen Skandals um zweifelhafte Praktiken in der Klimaforschung fordert von Storch auf seiner [Homepage](#) jetzt eine öffentliche Debatte über die Normen, nach denen Wissenschaft betrieben wird.

„Offensichtlich kann die Wissenschaft selbst nicht definieren, wie diese Normen aussehen sollten. Eine Hauptrolle in diesem Prozess sollten die Medien spielen – und es scheint, dass die Medien endlich anfangen sich ernsthaft dem Problem zu widmen. Ein Beispiel ist das [Wall Street Journal](#). In Deutschland beurteilen die

Journalisten diese Affäre moderater, wie z.B. im [Tagesspiegel](#)."

Konsequenzen fordert von Storch nicht nur für die moralischen und ethischen Richtlinien, unter denen Wissenschaft betrieben werden soll. Auch die Art und Weise, wie Forschungsergebnisse publiziert werden und vor allem wie die Daten für die Öffentlichkeit zugänglich gemacht werden sollen, bedarf nach seiner Ansicht einer dringenden Überarbeitung.

„Eine Schlussfolgerung sollte sein, dass das Prinzip nach dem Daten veröffentlicht werden müssen, damit Kontrahenten die Ergebnisse überprüfen können, wirklich verstärkt angewandt werden muss. **Eine andere Schlussfolgerung könnte sein, dass Wissenschaftler wie Michael Mann, Phil Jones und andere nicht mehr länger in Prozessen zur Begutachtung (Peer-review) oder an Beurteilungs-Aktivitäten wie dem IPCC teilnehmen dürften.**“

Konsequenzen auch in britischen Medien gefordert

Ganz allein steht der Deutsche mit dieser Forderung nicht da. Der bislang eher für seine unkritische Haltung der etablierten Klimaforschung gegenüber bekannte britische Zeitungsjournalist George Monbiot stieß ins gleiche Horn, als er in einem Artikel schrieb:

„Noch schlimmer ist es, dass einige E-Mails Versuche nahe legen die Arbeiten von Klimaskeptikern an der Publikation zu hindern oder diese aus dem IPCC-Report herauszuhalten. **Ich glaube, dass der Direktor des Instituts, Phil Jones, jetzt zurücktreten sollte.** Einige der Daten die in den E-Mails diskutiert wurden sollten neu analysiert werden.“

Es spricht für die journalistische Integrität von Monbiot, dass er in den Kommentaren im Anschluss an den Artikel offen bei seinen Lesern dafür um Entschuldigung gebeten hat, oft zu gutgläubig an das Thema Klima herangegangen zu sein.

„Ich bitte um Entschuldigung. Ich habe denen die die Beweise geliefert haben zu sehr vertraut. Ich habe sie bevorzugt. Ich wäre ein besserer Journalist gewesen, wenn ich deren Aussagen besser untersucht hätte.“

Währenddessen scheinen die Reaktionen auf die Affäre in Großbritannien langsam an Fahrt zu gewinnen. Der konservative Politiker und Journalist Lord Nigel Lawson hat eine [unabhängige Untersuchung gefordert](#), um die Vorwürfe über Datenmanipulationen aufzuklären. Lawson sah die Integrität der wissenschaftlichen Beweise für die globale Erwärmung als zweifelhaft an. Auch angesichts der Tatsache dass mit Hilfe dieser Daten politische Entscheidungen

gerechtfertigt werden sollen, die die ganze Welt betreffen, sei eine Überprüfung absolut notwendig.

Untersuchungen in den USA – Schweigen in Deutschland

Auch von jenseits des Atlantiks, dem zweiten Epizentrum des Daten-Skandals, kommen zunehmend Stimmen, die [eine genaue Untersuchung der Daten und E-Mails fordern](#). Schließlich handelt es sich bei einem Großteil der E-Mails um Korrespondenz zwischen englischen und amerikanischen Forschern. Laut Aussage des hochrangigen Republikanischen Vertreters Darrell Issa werden die Dokumente bereits von Ermittlern überprüft. Besonderes Augenmerk legen die Ermittler auf die Verwicklung des wissenschaftlichen Beraters des Präsidenten, John Holdren.

Was die Frage aufwirft, wann die Bundesregierung in dieser Sache aktiv werden will. Schließlich ist mit [Professor Stefan Rahmstorf](#) vom Potsdamer Institut für Klimafolgenforschung (PIK) und einflussreiches Mitglied im [WBGU](#) (Wissenschaftlicher Beirat der Bundesregierung für globale Umweltveränderung) möglicherweise auch ein hochrangiger deutscher Klimaforscher in den Skandal verwickelt. Und ebenso wie in Großbritannien und den USA hat auch hierzulande die Klimaforschung einen großen Einfluss auf politische Entscheidungen. Rahmstorfs Chef Hans Joachim Schellnhuber ist der Klimaberater unserer Kanzlerin.

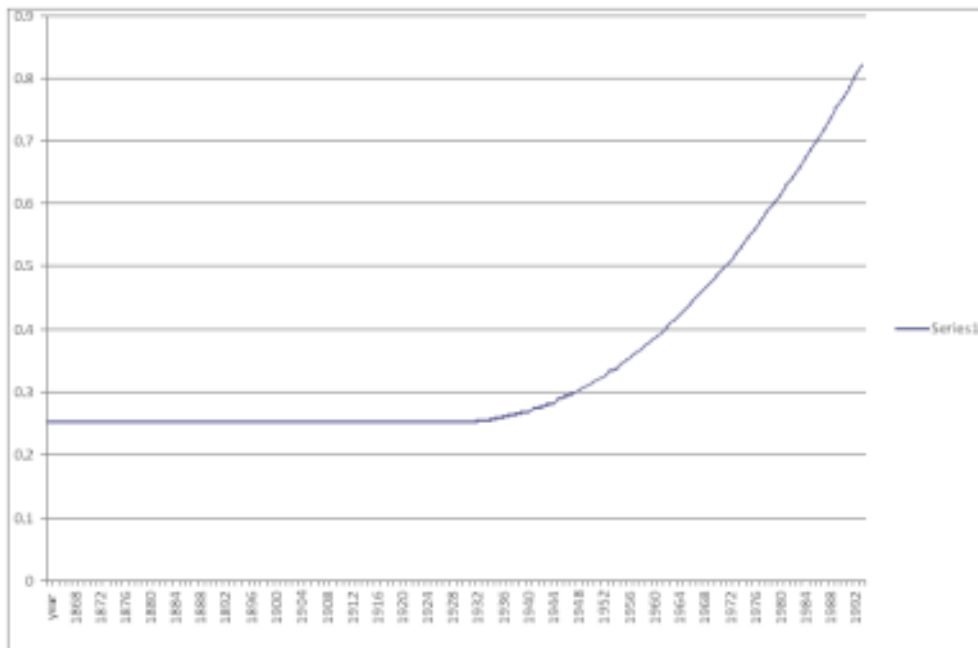
Zündstoff auch in den anderen Dateien

Nachdem anfangs hauptsächlich der Inhalt der über Tausend E-Mails gesichtet, analysiert und diskutiert wurde, wuchs auch das Interesse am Inhalt der Dateien im Ordner ‚Dokuments‘. Befanden sich darin doch fast 150 Megabyte an Dokumenten, Datensätzen und Programmcode. Bestimmt ließ sich darin einiges Verwertbares finden.

Und in der Tat, bereits erste Sichtungen brachten ans Tageslicht, auf welche Art die Klimawissenschaftler Daten manipulierten, die nicht das richtige, nämlich eine sich fortschreitende Erwärmung im 20. Jahrhundert, zeigten. In einem Programmcode fand sich zum Beispiel eine Prozedur, die ab 1930 eine künstliche Erwärmung in einem Datensatz produzierte. Ein Blogger kommentierte das mit diesen Worten:

From the file pl_decline.pro: check what the code is doing! It's reducing the temperatures in the 1930s, and introducing a parabolic trend into the data to make the temperatures in the 1990s look more dramatic.

Was der erwähnte Code mit einem neutralen Datensatz macht kann man in der folgenden Abbildung erkennen. Es wird eine Steigerung der Temperaturen produziert, wo diese in den Rohdaten gar nicht vorhanden ist.



Auch in vielen anderen Programmcodes finden sich Zeilen, die nahe legen dass im Programmcode Daten künstlich verändert oder durch Daten ausgetauscht werden, um eine Steigerung der Temperatur zu erzeugen, wo die Rohdaten stagnierende oder fallende Temperaturen zeigen.

Regarding the "upside down man", as Nick's plot shows, when flipped, the Korttajarvi series has little impact on the overall reconstructions. Also, the series was not included in the calibration. Nonetheless, it's unfortunate that I flipped the Korttajarvi data. We used the density data as the temperature proxy, as recommended to me by Antii Ojala (co-author of the original work). It's weakly inversely related to organic matter content. I should have used the inverse of density as the temperature proxy. I probably got confused by the fact that the 20th century shows very high density values and I inadvertently equated that directly with temperature.
